## Thursday 20 Octobre 2005

The following matters were discussed:

- Agendas for the Board of Directors meeting on 2 december and the General Meeting on 3rd december.
- Friday 2 Décember :

- Setting up Development Officers training courses and the selection of the priority countries:
- RDM presentation of actions for 2005/2006:

  - Assistance for countries equipment and teaching
  - Level 3 and Experts courses
  - General Secretaries

Matters of a general and policy nature were also covered:

- Renewal of the IRB/FIRA-AER agreement expiring on 31 december 2005.

- Election at the General Meeting of the FIRA-AER representative on the IRB (every 3 years)
- A request is going to be submitted to the VI nations to start discussion on the Seniors competition and possibilities for working together.
- The same approach should be made with the Women's VI Nations.
- A working group was formed (MM. EPALZA MARTINS ZANDER) to draw up a specification sheet for the hosting teams during the Seniors competitions. Presentation of its work during the General Meeting in Paris in December.
- An update was provided on the progress of the work on the communication and partnership dossier with LZA.
- Lithuania should give its decision concerning the postponing of the LITHUANIA ARMENIA match.
